

PROTOCOL ON COOPERATION BETWEEN THE MINISTRY OF FOREIGN AFFAIRS OF MONGOLIA AND THE MINISTRY OF FOREIGN AFFAIRS OF THE KINGDOM OF THAILAND

The Ministry of Foreign Affairs of Mongolia and the Ministry of Foreign Affairs of the Kingdom of Thailand, hereinafter referred to as the "Parties";

DESIRING to strengthen and further develop the friendly relations and cooperation between the two countries;

CONVINCED that a constructive dialogue regarding bilateral relations and an exchange of information on regional and international issues will contribute to a better mutual understanding and will promote a closer relationship between them;

HAVE AGREED as follows:

Article 1

The Parties shall hold regular consultations and exchange information on bilateral relations and cooperation, as well as on regional and international issues of mutual interest.

Article 2

The Parties shall agree through diplomatic channels on the members and level of the delegations, as well as the date, location and agenda of the meetings.

Article 3

The Parties shall exchange information and hold consultations on issues of common interest through their respective Embassies accredited in each of them, Permanent Representatives of Mongolia and the Kingdom of Thailand to the United Nations and other international organizations.

Article 4

The Parties shall promote exchange of visits, initially at the Director-General level, at any time appropriate or agreeable to both sides, to review and to assess the overall relations as well as to identify ways and means which are conducive to closer cooperation in all fields. The dates and venues of the visits as well as the agenda shall be jointly determined through diplomatic channels.

Article 5

The Parties shall consider rendering a mutual support in training and postgraduate training of young diplomats of both countries. The sending Party will cover the international travel expenses. The receiving Party will cover full boarding and lodging expenses of the persons sent according to this Protocol.

Article 6

- 1. This Protocol shall enter into force on the date of its signature and shall remain in force indefinitely.
- This Protocol may be denounced in writing, through diplomatic channels, at any time by either Parties subject to a prior notification of at least six months notice to the other Party.

PROTOCOL ON COOPERATION BETWEEN THE MINISTRY OF FOREIGN AFFAIRS OF THE KINGDOM OF THAILAND AND THE MINISTRY OF FOREIGN AFFAIRS OF MONGOLIA

The Ministry of Foreign Affairs of the Kingdom of Thailand and the Ministry of Foreign Affairs of Mongolia, hereinafter referred to as the "Parties";

DESIRING to strengthen and further develop the friendly relations and cooperation between the two countries;

CONVINCED that a constructive dialogue regarding bilateral relations and an exchange of information on regional and international issues will contribute to a better mutual understanding and will promote a closer relationship between them;

HAVE AGREED as follows:

Article I

The Parties shall hold regular consultations and exchange information on bilateral relations and cooperation, as well as on regional and international issues of mutual interest.

Article 2

The Parties shall agree through diplomatic channels on the members and level of the delegations, as well as the date, location and agenda of the meetings.

Article 3

The Parties shall exchange information and hold consultations on issues of common interest through their respective Embassies accredited in each of them, Permanent Representatives of the Kingdom of Thailand and Mongolia to the United Nations and other international organizations.

Article 4

Article 5

Article 6

- This Protocol shall enter into force on the date of its signature and shall remain in force indefinitely.
- This Protocol may be denounced in writing, through diplomatic channels, at any time by either Parties subject to a prior notification of at least six months notice to the other Party.
